

## **Financial Evaluation**

Price quotes will be evaluated only for bidders whose technical proposals achieve a minimum score of 70 points in the technical evaluation.

Price quotes will be evaluated based on their responsiveness to the price quote form. The maximum number of points for the price quote is 100, which will be allocated to the lowest total price provided in the quotation. All other price quotes will receive points in inverse proportion according to the following formula:

# ANNEX II: TERMS OF REFERENCE (TOR)

Implementation of a Reality Check Approach in Zambezia and Nampula under Rapariga Biz Programme

## 1. Introduction

Girls and young women in developing countries face systematic disadvantages according to a wide range of indicators, including health and nutrition, education, protection, labor force participation and the burden of household tasks (Action for Adolescent Girls, UNFPA 2014).

Worldwide, an estimated 16 million girls between 15 and 19 years old give birth each year with 90% of those adolescent births among the 15-19 year olds occur within marriage (Girlhood, Not Motherhood, UNFPA 2015). For some girls and young women, pregnancy and childbirth are planned and wanted, but for millions of other women and girls this is unintended (Action for Adolescent Girls, UNFPA 2014). For some young women, pregnancy and childbirth are planned and wanted, but for millions of other women and girls this is unintended (Action for Adolescent Girls, UNFPA 2014).

Research shows that adolescence is the time where the most essential decisions shaping girls' lives are made, yet traditional youth programming tend to overlook the specific barriers and needs of the girls and young women. Therefore, it is fundamental to place the girls and young women at the center of their own development and undertake a more focused, holistic and integrated approach to respond to their needs (Action for Adolescent Girls, UNFPA 2014).

Mozambique has made progress to empower girls and young women over the past decades, yet still obstacles remains to reach national and global commitments. Many girls and young women are still subject to gross gender discrimination and inequalities that prevents them from reaching their and society's full potential. In response the first joint UN programme (UNESCO, UNFPA, UNICEF, UN WOMEN) for adolescent girls in Mozambique, Rapariga Biz was launched in August 2016 and targets 1 million vulnerable adolescent girls with empowerment, sexual and reproductive health, leadership, citizenship and human rights with the goal to prevent child marriage and teenage pregnancy.

# 2. Situational Analysis

Mozambique ranks among the worst countries in the world on several indicators on girls and women's rights and wellbeing. Girls and young women face a wide range of challenges, including entrenched gender discrimination, harmful practices such as child marriage, widespread gender-based violence and high rates of adolescent pregnancy, which affects their possibilities to reach their potential.

In comparison to boys and young men, girls and young women are exposed to sexual abuse and exploitation in school and at home. 70% of schoolgirls know of cases of teachers having sex with girls in exchange for grades. 22.4% of girls and young women between 15-19 years have been victims of physical violence according to 2011 DHS.

Mozambique currently holds the 7th highest early marriage prevalence rate in the world with 48% of young women between 20-24 years marrying before 18 years (DHS 2011), and almost one out of five girls (17.7%) is married before turning 15 (MICS, 2008). HIV prevalence among young women are also high compared to young men in Mozambique, it is currently at 11,1% among 15-24 years girls and young women , while only at 3.7% among boys and young men.

According to 2015 Survey by the Ministry of Health (IMASIDA 2015), 46% of girls between 15-19 years have been pregnant at least once. Early pregnancy multiply the risks to girls' health, increasing the likelihood of pregnancy complications such as obstetric fistula, or even die from pregnancy-related causes. Pregnancy

can also force girls to drop out of school, limiting their future potential. In Mozambique, girls' primary school net enrolment stands at 84 per cent, but by secondary school, their enrolment drops to 17 per cent (World Bank, 2014).

# 3. Objectives

Stemming from the ethnographic research tradition and according to the program proposal for Action for Girls and Young Women's Sexual and Reproductive Health and Rights in Mozambique (Rapariga Biz), the UN agencies plan to integrate a Reality Check approach in the Program to complement its monitoring and evaluation efforts. The approach is expected to:

- a) Increase the understanding of the qualitative dimensions and factors directly and/or indirectly influencing the high rates of early marriage and early pregnancy in Zambézia and Nampula Provinces;
- b) Generate evidence through the Rapariga Biz to build up a more strategic, focused, holistic and integrated approach to respond to girls needs and place the girls and young women at the center of their own development
- c) Inform and influence the national discussion on girls and young women's sexual and reproductive health and rights.

#### 4. Methodology

To improve the knowledge of different qualitative dimensions and factors influencing girls and young women's sexual and reproductive health and rights, the use of a Reality Check approach is recommended. The concept should be characterized by the from-below perspective, analyzing in the context of the local populations. Through the **Reality Check**, the knowledge is deeply enhanced on aspects of:

Poverty: Survival strategies of men, women, boys and girls; and Poverty dynamics

**Sociocultural Norms and Practices:** Power relations; Socialization processes; Gender relations related to SRHR; Expectations of masculinity and femininity

Agency of Girls and Young Women: Vulnerability; Powerlessness; Aspirations

The proposed methodology demands:

- 1) Immersion with selected mentors and young girls;
- Focus group discussions with mentors, young girls and boys;
- 3) Semi-structured, individual key informant interviews with influential people, men and women who have influence over decision making, embodiment and opinion making of social and cultural norms related to the sexuality and sexual identity of girls. This may include traditional midwives, community leaders, traditional leaders and initiation rites leaders, among others;
- 4) Semi-structured, individual key-informant interviews with men who are important in the lives of the selected girls (e.g. partner, boyfriend), if the girls consent to open the data collection to them and if they are accessible;
- 5) Focus group discussions with participatory exercises with youth and adults (separately by age and gender);
- Field observation of youth in collective settings, such as leisure sites or other youth gathering sites;
- Key literature review (KAP study, national Demographic Health Survey, Ligada study on formal female employment, among others).

Interview guides and participatory exercises has to be drafted to address specific research themes and target groups. However, the reality of the field will orient the actual conduct of the study. The interview guides will therefore serve more as a point of the departure to kick-off the study. As the researchers come

in touch with the local reality, they will adjust the methods as needed to gain as comprehensive understanding as possible of the given research topic.

The analysis method will be largely based on qualitative content analysis, which triangulates the field results with the findings of the literature review for the production of the research report. The report shall be discussed with UNFPA prior to its finalization, and it is recommended to disseminate its results with relevant central, provincial and district level authorities and implementing organizations.

Due to budgetary constraints, the Reality Check should take place in no more than four sites covered by the Rapariga BIZ Program; two in Zambézia Province and another two in Nampula Province. These sites will be defined at the Inception stage, in consultation with UNFPA.

#### 5. Work Plan

In the context of the Rapariga Biz, the Reality Check is planned to carry out in 2 steps:

- a) Inception: to get familiar with the context, literature review, select the study sites and further refine the methodological choices of the research, based on an inception visit to the research sites and a thorough technical discussion with UNFPA. The report will specify the evaluation methodology determining thereby the exact focus and scope of the exercise, including the evaluation questions, the sampling strategy, critical analysis of the quality of provided documents and the data collection strategy and instruments/tools.
- b) Research: proceed with organization and plan of the field work; technical preparation of field team; data collection in the selected sites, in both provinces simultaneously; clean-up of field notes and data analysis; production of the Report combining the findings of the data collection; and presentation of the Report findings in the annual Rapariga Biz meeting.

# 6. Deliverables

The main deliverables are the i) Inception Report with protocol design, which should not to exceed ten pages (without annexes), submitted at least three weeks after contract signature, and is shared with the UNFPA for comments and clearance and ii) the Reality Check Report (in both English and Portuguese languages in electronic versions).

### 7. Supervision

Coordination and supervision for the implementation of the Reality Check will be provided by Youth National Programme Officer and the M&E Officer in line to the Rapariga Biz programme.

### 8. Background materials

Rapariga Biz main program, infographics, and report documents; Baseline; Logframe; PGB evaluation; Access to Kirí Biz (RTM mentors).

#### 9. Timeline

The duration of the Reality Check will be four (4,0) months in total, between August and November 2018.
